13.21 Apologies for Absence

Apologies were received from Cllr K Iddon.

14.21 Declarations of Interest

Councillors Fenemore, as a member of Croston Sports Club, and Councillors Almond, Myers and Paillusson, as trustees of Croston United Charities, declared non-pecuniary interests in planning applications relating to Croston Sports Club.

15.21 Minutes of the Meeting held on 13 January 2021

Resolved: the Minutes (as circulated) were approved and signed by the Chairman as a correct record.

Resolved: Standing Orders were suspended.

16.21 Public Participation

A representative of the Croston Volunteer Litter Picking Group provided information on the work carried out. The representative advised of large amounts of litter in the village and queried the measuring of the effectiveness of a staff member and suggested a review of the areas covered.

A member of the public provided detailed information on a suggestion for the setting up of a Community Land Trust to provide ecologically sensitive, low density development, comprising of properties which would meet local needs, on the land to the south of Brookfield.

United Utilities will inspect the problem involving a problem with the sewer pipe on Footpath 1.

Contractors carrying out work on Westhead Road had been parking on Farmhouse Court.

Cars not displaying badges had been parking in the disabled parking space on the Village Green car park.

Resolved: Standing Orders were restored.

17.21 Planning Matters

21/01389/OUTMAJ Outline application for the construction of sports pitches and multi use games areas including matters of access and layout with matters of appearance, landscaping and scale reserved at Croston Sports Club, Westhead Road

20/01390/OUT Outline application for the erection of a building comprising community facilities and a building to provide changing facilities with associated car parking and landscaping including matters of access and layout with matters of appearance, landscaping and scale reserved at Croston Sports Club, Westhead Road

The potential increase in traffic caused by users of the facilities from outside the village and an increase in on street parking were mentioned. It was pointed out the land has been designated for housing in the site suggestions put forward by Chorley Council in the Central Lancashire Local Plan and this would, potentially, result in far more traffic.

Resolved: the support of the Parish Council for both applications is to be submitted to Chorley Council.
