# 14.22 Public Participation

Problems with sewage coming from drain covers along Grape Lane were reported. This has been reported to the Environmental Health Officer. This will also be raised at the next meeting of the River Douglas Catchment Area Group.

Flooding on Carvers Brow, due to faulty valves in the river wall, resulting in residents being unable to leave the village has been reported to Lancashire County Council.

United Utilities had inspected the leaking sewer pipe on the public footpath running alongside the railway line. Problems exist with the United Utilities mapping system for the pipes.
