88.19 Minutes of the Meeting held on 10 July 2019

89.19 <u>Public Participation</u>

A resident queried the current position regarding the Meadow Lane bridge. Councillors advised a Group is to be formed along the lines of the Flood Group and an article inviting residents to join has been included in the newsletter.

The resident queried the current situation with repairs to the damage to the entrance to Croston Park. Councillors advised this was understood to be in the hands of the insurers.

The public footpath on the site of the Former Mill Hotel within the new planning applications was queried. Councillors advised any diversion would have to be approved by Lancashire County Council. It was mentioned all public footpaths in the parish should be walked and inspected.

Information relating to the pavement by the Village Green was provided. The problem had been found to be a collapsed culvert which takes surface water from Out Lane to the river.

A resident had mentioned the lack of a village entrance sign on Moor Road. As the signs were a Neighbourhood Priority this will be raised at the Western Parishes Neighbourhood Area meeting.
